Reduction in forest cover in Northeast India

531. MS. SUSHMITA DEV:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the forest cover reduction in the North East region in India yearly from 2017 to 2021, State-wise details thereof;
- (b) whether Government has conducted consultations with stakeholders from the North East region regarding proposed amendments to the Forest Conservation Act;
- (c) if so, the details of the consultation and if not, the reasons therefor; and
- (d) the reasons why India did not join 100+ world leaders in signing the Glasgow Declaration in November 2021, to halt and reverse deforestation and land degradation by 2030?

ANSWER

- (a) Forest Survey of India (FSI), Dehradun, an organization under the Ministry carries out the assessment of forest cover of the country biennially since 1987 and the findings are published in India State of Forest Report (ISFR). The forest cover assessment is a wall-to-wall mapping exercise based on remote sensing supported by intensive ground verification and field data from National Forest Inventory. As per latest ISFR 2019, the total forest and tree cover of the country is 8,07,276 square kilometers which is 24.56 % of the geographical area of the country. There is an increase of 13,209 square kilometer of forest and tree cover at the national level in the ISFR-2019 as compared to the ISFR- 2015. The State wise details of change in forest cover in the Northeast region in India between ISFR 2017 to ISFR 2019 is given in **Annexure**.
- (b) & (c) The Ministry has received suggestions from various Ministries, State Governments and stakeholders regarding amendments in the Forest (Conservation) Act, 1980. In this regard, a public Consultation paper containing the details on the proposed amendments was circulated for inviting comments/suggestions from various stakeholders including those in the Northeast region in October, 2021.
- (d) India has not joined, due to reference to trade as an area in the Glasgow Declaration on Forests and Land Use in November 2021.
